Historical Sketch

In 1967 a committee was appointed by the chair of the Division of Girls and Women's Sports within the Kentucky Association of Health, Physical Education and Recreation to study the expanding interest in women's intercollegiate athletics. It met for the first time on December 2, 1967, with the purposes to develop state guidelines and policies for the development of intercollegiate programs for college women. Representatives from nine institutions attended this first meeting. In 1970 the first formal operating code was passed and the committee was changed to the KWIC (Kentucky Women's Intercollegiate Conference). The first state tournament was held in 1971, and the KWIC participated in the first AIAW (Association for Intercollegiate Athletics for Women) regional tournament and national tournaments in 1972.

Over the course of the KWIC's history, many Kentucky colleges and universities have at one time been members, with the largest membership enrollments coming in the late 1970s and early 1980s. In 1981, however, the NCAA established championships for women's Division I sports, and there was no longer a need for Division I Kentucky schools to participate in the KWIC state tournaments. NCAA participation began the slow but inevitable erosion of the KWIC as an athletic conference.

In 1996 the KWIC changed its name to the Kentucky Women's Intercollegiate Consortium, and abandoned the state tournaments it had sponsored since its inception. Its focus became the promotion of women's intercollegiate athletics in Kentucky, and to provide opportunities for professional development. This mission is what continues to drive the KWIC today.

Scope and Content Note

The KWIC Records consists of tournament records, meeting minutes, financial records, member correspondence, photographs, and handbooks. The records cover the entire period the KWIC was a conference. From the point it became a consortium, the records become a bit more intermittent. These records are divided into five series: **Tournament Records, Coaches/Season Reports, Administrative Records, Awards Records, and Photographs.**

The **Tournament Records** series is arranged alphabetically first by sport, and then chronologically by school year. Each folder represents one school year, except in cases where the records from that tournament require more than one folder. Within each folder, the records are further subdivided into eight categories: *Correspondence, Tournament Eligibility Affidavits and Team Rosters, Programs, Tournament Schedule, Tournament Scoresheets, Tournament Results, Publicity, and Tournament Evaluations and Reports.* Not every folder will contain all eight sections. The *Correspondence* sections contains mailings that were sent to the participating member schools in that particular sport, as well as correspondence sent between members regarding various aspects of the tournament. This section generally does not contain

any correspondence that deals with the financial side of the tournament. Those correspondence will be found in the *Tournament Evaluations and Reports* sections, as it seems more appropriate to keep these items with the tournament financial reports. The *Tournament Eligibility Affidavits and Team Rosters* sections contain the affidavits of eligibility for each participating schools' athletes, as well as team rosters. If an athlete were not listed on their school's eligibility affidavit, she could not participate in the tournament. The *Programs* section contains official programs distributed at the tournament. The *Tournament Schedule* section contains the schedule of the tournament, often including the times for each game, match, etc., as well as the field or court it was to be held. This section occasionally holds the officials' schedules, indicating which game or match they would be officiating and the time of said event. The *Tournament Score sheets* section contains score sheets used by the official score keepers to record the statistics of each game or match. The *Tournament Results* section lists the results of the tournament, often including a list of the all-tournament team. The *Publicity* section holds posters, fliers, and newspaper clippings that publicized the tournament. The *Tournament Evaluations and Reports* section often includes the tournament commissioner's evaluation, as well as evaluations filed by participating coaches. It also includes the financial reports of the tournament, as well as correspondence pertaining to tournament finances. Occasionally a report from a coaches' meeting held shortly before the tournament is also included.

The **Coaches/Season Reports** series is arranged chronologically first by school year, then alphabetically by institution, and finally alphabetically by sport. Each coaches/season report is comprised of three parts: season schedule with win/loss record and final scores, team roster, and tournaments entered. Other records, such as those that list the number of athletes participating in each sport for that school year, are occasionally included, and will be located at the beginning of the folder, since these records pertain to no one school in particular.

The **Administrative Records** series contains financial records, member correspondence, board/business meeting minutes, membership forms, handbooks, and member/coaches directories. The financial records include ledgers, budgets, proposed budgets, treasury reports, and correspondence. Member correspondence is any communications that do not belong with either the financial correspondence, the tournament correspondence, or the awards correspondence. All of these records are arranged chronologically.

The **Awards Records** series contains lists of award winners, correspondence, and voting ballots.

The **Photographs** series is arranged alphabetically by sport. Each folder contains a single sport.
